



TERMS AND CONDITIONS

FBA Your Backyard Photo Competition

Please read these Terms and Conditions carefully before participating in the FBA Your Backyard Photo Competition (“the Competition”). By submitting an entry, participants confirm they have read, understood, and agree to these Terms and Conditions. If you do not comply with these Terms and Conditions, you will not be eligible to win.

1. Promotor

2. Eligibility

- Entry is open to individuals who work, play, study, or are residents of the Fitzroy Basin region of central Queensland (CQ), Australia
- Individuals under 18 years of age must have the consent of a parent or guardian
- An entry must be an individual and not a company or organisation
- Employees of the Promoter and their immediate family are not eligible to enter
- Entry is free (unless otherwise stated)

3. Competition Period

- The Competition will open on Wednesday 1 April 2026, 9:00am (AEST)
- The Competition will end Thursday 1 April 2026, 5:00pm (AEST)

Entries received outside this period will not be accepted.

4. How to Enter

To enter, participants must:

- Submit an original photograph via <https://survey123.arcgis.com/share/fe1aea1c055a4648a1629a0dab4755a2>
- Include required details:
 - Name and contact information
 - Image caption and location

Entry requirements:

- Entries must be submitted in JPEG format and not exceed (20MB)
- Photos containing offensive, defamatory, or inappropriate content will be disqualified
- Entrant must own rights to the image
- The photo must not infringe any third-party rights including copyright, trademark, or privacy rights
- If people are identified, the entrant must have permission

5. Entry Conditions

- Multiple entries are permitted
- Entries must not contain:
 - Offensive, defamatory, or inappropriate content
 - Content that breaches any law
- Entries will be deemed invalid if they are incomplete (missing information)



- The Promoter reserves the right to disqualify any entry that does not comply

6. Judging and Winning Selection

- Entries will be judged by a panel of 3 judges selected by the Promoter
- Judging will be based on creativity, originality, quality, composition and storytelling
- Judging will take place on Wednesday 6 May 2026
- The judge's decision is final, and no correspondence will be entered into

7. Prize

- There will be 1 major prize. The winning entry will receive a holiday package at Great Keppel Island including: 2 night stay (Friday-Sunday) for 2 adults and 2 kids at Keppel Hideaway glamping tent accommodation, ferry transfers, meals included (breakfast, lunch and dinner). Snorkelling tour with Keppel Dive and Water Sports included

- By submitting your photo(s), you confirm that you understand and accept these terms. You also warrant that you are the sole copyright owner of the submitted photo(s) and that the photo(s) do not infringe any third-party rights, including copyright, privacy or publicity rights.

Entrants retain ownership of their photographs.

10. Privacy

- By entering the Competition, participants consent to the collection and use of their personal information for the purpose of administering the Competition and awarding prize.
